Subject: Flood Protection Culvert MT 16 & Town of Culbertson

The Montana Department of Transportation (MDT) is in receipt of your letter dated March 5, 2001, in which your firm inquired about the possibility of MDT installing an additional culvert in MT 16, just north of Culbertson.

Your letter requested that MDT consider the installation of an additional culvert just north of the rodeo grounds as a flood prevention project for the Town of Culbertson.

Since your letter submittal to MDT, the District has nominated a project to install an additional culvert at milepost 88.2 on MT 16. MDT held a field review of this site on May 15, 2001. The process for project development within the State of Montana is as follows:

- District nominates project for use of Federal and State funds.
- Nominated project is submitted to Montana Transportation Commission for approval.
- Upon receipt of Commission approval, project is submitted to Federal Highway Administration (FHWA) for review and approval.
- Upon receipt of FHWA approval, project is programmed into MDT's state wide program.

Once the project is programmed, the design process commences. This design phase will include a hydraulic study to determine the size and components for the additional culvert. Also, the project competes for funding along all other projects within MDT's long range plan. We would envision that the earliest construction would commence at this site, is in the middle of 2002. Actual project delivery would depend on funding availability and project development involvement.

Page Two May 25, 2001

Your letter mentions that approximately \$65,000 to \$75,000 would cover the cost of installing an additional culvert at this site. MDT's preliminary estimate puts the project cost at in excess of \$250,000. In addition to the cost of the culvert, the culvert will require foundation stabilization, culvert end treatments, detour for culvert installation and right-of-way involvement.

Stagecoach Casino. Mark & Kristie Mahlen want to install an underground heat source pump for the Stagecoach. Mark said they would need to come out into the alley to drill holes to install the PVC Pipe Loop which would be 6-7 ft. deep, and was requesting permission to be in the alley. Attorney Hennessy thought there may be some requirements under the Buried Facilities Statute. Town will need a Plat Map, 99 yr. easement and a building permit.

Bernie W. Finnicum made a motion to approve the Stagecoach Casino request to encroach the alley for a portion of the underground heat source pump system, pending receipt of a building permit, recordable plat map and easement. Paul S. Finnicum seconded the motion. All voted in favor of the motion. MOTION CARRIED.

 $\overline{\text{IV}}$ . Ken Youngquist made final application for a Construction Permit for  $\overline{1}$  channel #34 for Culbertson. Culbertson's original application was for 2 UHF channels #34 & #36. Ken Youngquist recommended that Culbertson purchase a 100 watt Translator and Omni Directional Antenna. The more power at the tower the less it costs for those in town purchasing equipment. Homes not on the cable system would need an 8' antenna. Culbertson could spend \$200. - \$300. to apply for a special permit which would only take 2-3 weeks to get the license, but to order and receive the equipment will take 1 to  $2\frac{1}{2}$  months. Culbertson should then get it into the Cable TV System. One translator for one channel and one antenna for two channels.

There was discussion on how other towns pay for a television station. Circle charges \$20./yr. to any customer using their channels. The south 1/3 of McCone County has a TV District. Can only have a tax district in your own county. If Bainville residents were interested in the Montana Station they would need a 1 Watt Translator (approximate cost \$4500) to receive the signal from Culbertson along with an antenna on a building. If Culbertson and Plentywood both get set-up, Froid will also receive the signal.

Operating and maintenance of a 100 Watt Translator is \$140.00/yr. for electricity and \$550.00/yr. for insurance. Maintenance is minimal with solid state equipment. Circle is maintaining 5 older units for #350.-\$400./month.

The television station is a long term project 25 years plus.

Plentywood will not make any decisions about getting the station to their community until Culbertson makes a decision on the equipment.

Dry Prairie Rural Water. There was discussion about the water storage tanks and who should own the tanks. What level of water should be maintained in the tanks for fire flow/protection? Robert Jasper will try to find this out. Medicine Lake is having water quality problems. Dry Prairie Rural Water wanted to know if Culbertson would work with DPRW engineer to see about the possibility of servicing McCabe, Froid and Medicine Lake. What is our plant capacity?

Paul S. Finnicum made a motion to allow DPRW to review our water plant specifications and capacity to see if it is possible to service McCabe, Froid and Medicine Lake. W. Bruce Houle seconded the motion. All voted in favor of the motion. MOTION CARRIED.

The state installed "No Parking - Bus Loading Zone" signs after our prior request, but this has the bus drivers thinking they can park in that area. Street Lighting - Christmas Decorations.
